

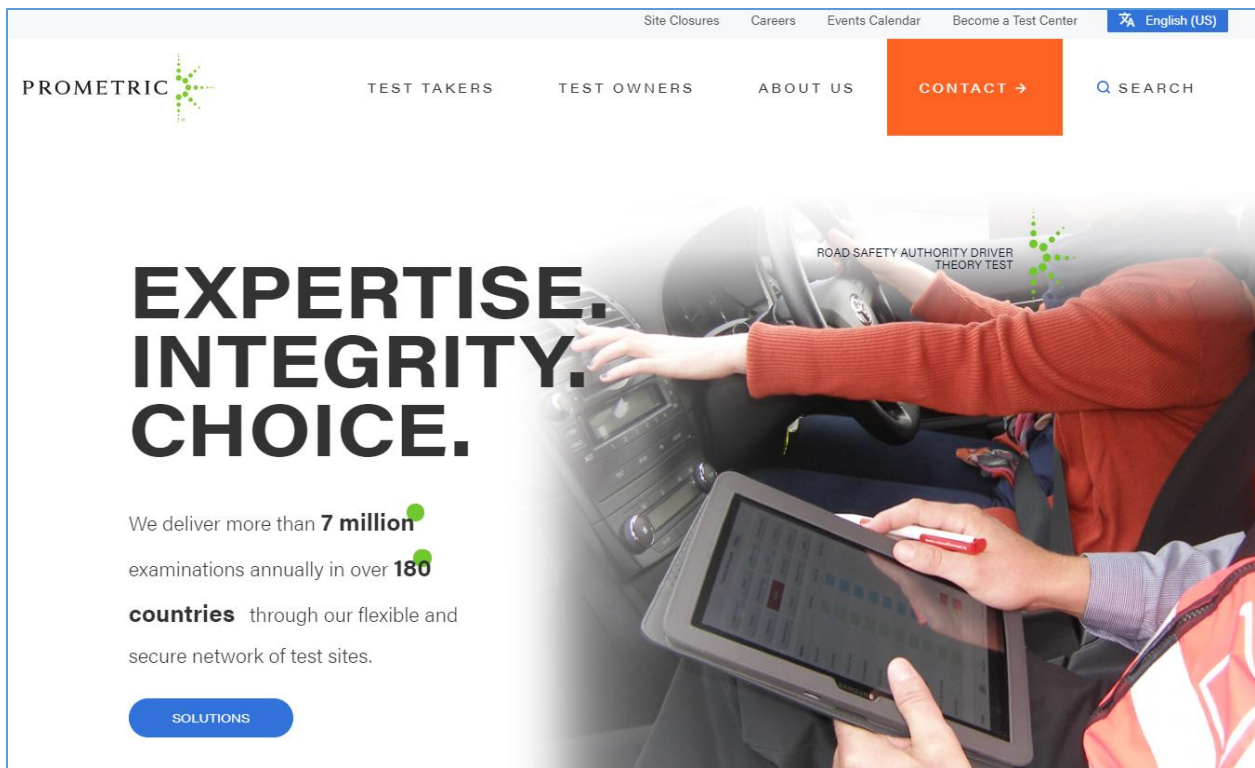

ASQ is planning to migrate from our legacy Scheduling system to, ProScheduler. The migration date is still to be determined.

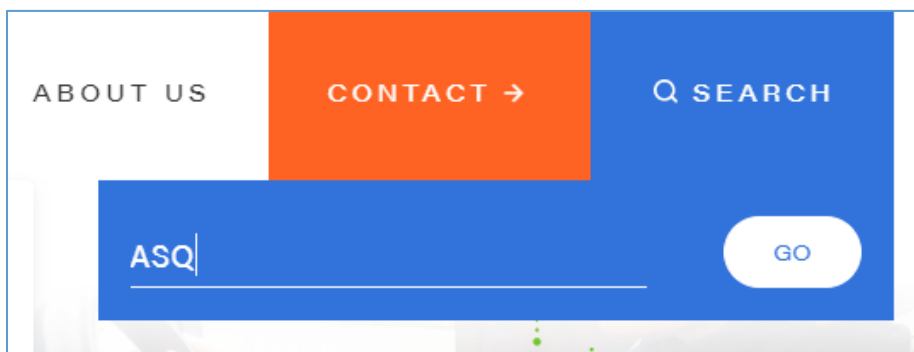

You must have registered for your examination(s) with ASQ prior to scheduling your testing appointment at a Prometric Testing Center. What to Bring to the Testing Center
You will be required to present one valid, government-issued photo ID with a signature (e.g., driver's license or passport). Your name on the ID must match the name on your scheduling notification. No expired ID's will be accepted. If you are testing outside of your country of citizenship, you must present a valid passport. If you are testing within your country of citizenship, you must present either a valid passport, driver's license, national ID or military ID. All other personal items must be locked in a locker for test security purposes, so please limit what you bring to the testing center.

What Time to Arrive at the Testing Center
Plan to arrive 30 minutes before the scheduled appointment to allow time for check-in procedures. If you are late in arriving, you will not be allowed to test and will forfeit your exam fee.

Appointment Reschedule/Cancellation: If you wish to change your exam appointment date or time, you must do so at least 5 days prior to your appointment using the Reschedule/Cancel option on [Prometric's website](#), or by contacting Prometric's automated voice response system at 800-369-5949 (in North America) or Prometric's Regional Registration Center (outside North America); the website is available 24 hours a day, 7 days a week. There is a \$70 fee for changing an appointment. No


